- 1. Apologies for Absence were received from, Mr Terry Woods, Mr,R Garforth, Mr Richard Horsfall
- **2**.The minutes of the meeting of the Parish Council held on Monday 21 January 2011 were circulated prior to the meeting were taken as read and the chair was authorised to sign them.

3. Matters Arising

- 3.1 The Clerk informed the Council that Park Services had recently installed the new litter bin in Pilley Pocket Park, alongside the pic nic bences. Noted.

Enhancing the Village. Nothing further to report at this stage, Cllr Kate Dodd is to review and report on any actions/progress at the next meeting.

7. Group Reports

TCA, no representative able to attend last meeting, although it was noted the date of the Annual Summer Gala will be Sat 2 July 2011, Clerk to book the Park with Park Services. Agreed.

Crime and Safety.Partnership. Several crime incidents were reported including: theft of a Blackberry stolen from McDonalds, Burglary at Pilley Hills, theft from a vehicle at Pilley Green, Sheds theft – Sheffield Rd, Hoyland Common. Youths are congregating and drinking alcohol in Jubilee Park, this situation is being monitored. It was noted that the gates to the Motocross track have been padlocked, noted that a Silver Astra car has been following single lady drivers on the road towards Worley, noted.

TPEG, It was reported that the meetings of TPEG are now taking place in the Mission Church. It was confirmed that Trevor Main, BMBC who has recently been working closely with the Group will remain in his post. The "raising" of the Tankersley stone is to be put on "Hold" for the time being. Ideas and cost implications are currently being assessed. Noted

Forge Partnership The main focus of the last meeting was re Elsecar/Jump budget reductions. It was reported that the Rockingham Centre's facilities was being very well utilised by a wide variety of community Groups.

- **8.Affordable Housing** Gillian Wilkinson, BMBC,Stratgeic Housing attended the meeting to report on the progress of proposed developments in the area. As previously outlined 2 sites have been identified. One being the site off The Avenue, Pilley and the 2nd site being adj to Glebe Court. Gillian explained that these are ideas only at this stage and not approved plans, and at this stage they are looking for agreement from TPC. Gillian presented information to the Council re optional plans and summary of waiting lists etc. After consideration and a majority vote, Option 2, a mix of houses and bungalows was considered to be the preferred option for the site off The Avenue,. TPC accepted favourably the proposals which had been put forward, Gillian agreed to move ahead with Planning Proposals. Noted.

It was considered by the Council that this would be good value, Clerk to confirm booking. Agreed.
