1. Apologies

- 1.1 Tankersley Parish Council noted that apologies had been received from Cllrs Jarvis and Sowersby
- **1.2** Tankersley Parish Council did not consider that the absence of Cllrs Jarvis and Sowersby from the meeting should be authorised.
- 1.3 The Clerk confirmed that there are no concerns with the attendance record of Councillors.
- 2. Declarations of Interest and Dispensation Requests
- 2.1 Cllr Crossley declared an interest in TCA.
- 2.2 The Clerk confirmed that no dispensation requests had been received.

4 Minutes

The Minutes of the Ordinary Parish Council Meeting held on 20 February 2023 were agreed as a true and accurate record. Cllr Crossley proposed and Cllr Leake seconded that Cllr Lodge as Chair of the meeting be authorised to sign the Minutes as a true and correct record. Cllr Lodge signed each page of the Minutes

 Business Raised During Public Question Time No business was raised.

6. Neighbourhood Plan

- 6.1 Cllr Leake proposed that the Chair of the Neighbourhood Plan Working Group be allowed to speak during this item 6 of the agenda. Cllr Crossley seconded the motion and the Parish Council voted and RESOLVED that the Chair of the Neighbourhood Plan Working Group should be allowed to speak on this item of the agenda.
- The Chair of the Neighbourhood Plan Working Group informed the Parish Council that the Working Group had met on Thursday 16 March. The Working Group hoped that Helen Willows would attend their next meeting. The Group had written to the Cabinet Member for Environment and Highways requesting a meeting to discuss transport issues in the Parish.
- 6.3 Tankersley Parish Council noted that the Parish Council's application under Regulation 5 of the Neighbourhood Planning (General) Regulations 2012 for the whole of Tankersley Parish to be designated a Neighbourhood Area had been approved.
- The Clerk explained that the application forms to apply for grant funding from Locality were not available.
- 7. Tankersley Parish Council RESOLVED that due to the nature of the business to be considered the public and press should be excluded from this part of the meeting under Section 1(2) of the Public Bodies (Admission to Meetings) Act 1960
- 7.1 The Chair informed the Parish Council about the meeting he and the Clerk had attended with the Chair and the Clerk with the Monitoring Officer and Head of Elections on 6 March regarding the conduct of a resident.

The Parish Council were informed that Barnsley MBC Legal Department had served a cease and desist letter on the resident in order to stop the numerous abusive and vexatious emails being sent to Councillors and the Clerk. Should the resident breach this order then further legal action was possible.

The Parish Council was also informed that in the light of Barnsley MBC officers witnessing the residents disruptive conduct in the February Parish Council meeting the resident had been served with an order banning attendance from the March and April Parish Council meetings. Further legal action would be taken if the ban was breached.

- 7.2 Tankersley Parish Council RESOLVED to adopt the Business Continuity Plan.
 - 7.2.1 Tankersley Parish Council considered the practical implications for the Business Continuity Plan in the light of the upcoming local elections. Cllr Crossley pointed out that as he had been one of the targets of the resident's numerous abusive emails and abusive comments in Parish Council meetings since November 2021 he would not be re-standing as a Parish Councillor in May
 - 7.2.2 Tankersley Parish Council considered the projects that Cllr Crossley was involved in and the implications for the new Parish Council after the elections. Particular attention was paid to the Sponsored Hanging Baskets. Tankersley Parish Council RESOLVED that if possible, the Sponsored Hanging Basket project should be transferred to the TCA. This would also impact on the Budget adopted by the Parish Council in January.

Tankersley Parish Council RESOLVED to defer adopting the Model Code of Conduct to the April meeting.

9. Hanging Baskets 2024 and Health and Safety Issues

The Clerk and Cllr Crossley informed the Parish Council about the discussions that had been held by Barnsley MBC regarding hanging baskets across the authority. Barnsley MBC had informed all Parish Councils that risk assessments of additional lamp-posts would be required for hanging baskets in 2024 and future years.

10. Millennium Plates

Tankersley Parish Council RESOLVED that the Millennium plates should be included in the Exhibition being planned by the Church for the Coronation. This would give residents another opportunity to obtain a Millennium plate.

11. Application for Funding for a new SID
