# 315. TO DISCUSS TANKERSLEY PARISH COUNCIL NEWSLETTER. (item 9)

It was also agreed to include information from TCA, TPEG and the neighbourhood plan. It was agreed for the Clerk to start pulling together a draft which would be reviewed at the next meeting.

# 316. TO DISCUSS VACANCIES AND AGREE CO-OPTION FOR TPC (item 10)

#### PARISH COUNCIL MEETING : 24 FEBRUARY 2025

Two members of the public attending the meeting had filled out the cooption application. Both attendees gave a brief summary of themselves and why they wanted to become councillors. The attendees were asked to leave the room after which a vote was held. It was agreed by all councillors in attendance to co-opt both N. Goodwin Tudor & J. Mayes to Tankersley Parish Council. Both signed documents to support this.

# 317. TO REVIEW TPC RISK ASSESSMENT AND REVIEW ITS RELEVANCE TO THE PARISH COUNCIL. (item 11)

The risk assessment was reviewed at length and it was agreed that the risk assessment still reflected the duties of TPC.

#### 318. TO DISCUSS PLANS FOR BROAD INGS WOOD. (item 12)

Cllr Cocking provided an update on Broad Ings Wood and some dead trees located near the roadside. The Clerk advised that any activities in the wood MUST be first agreed by the Parish Council. It was agreed for the tree surgeon and the member of the public mentioned by Cllr Cocking, to attend the annual Parish Meeting and provide advice on Broad Ings Wood.

# 319. TO DISCUSS AND AGREE ARRANGEMENTS FOR VE DAY – 8TH MAY 2025 (item 13)

It was agreed to hold a Beacon Lighting Ceremony on 8<sup>th</sup> May 2025 to mark VE day. Cllr J Mayes agreed to provide barriers for the event and it was agreed to source wood for the event. It was agreed to defer arrangements to the next meeting.

### 320. TO DISCUSS GRIT BIN ARRANGEMENTS/LOCATION/FILLING AND GLEBE COURT. (item 14)

Cllr P. Simpkin advised that all grit in the container had been used to fill the grit bins, 6 bags are needed to fill each bin. 8 black Parish Council grit bins are within the parish. It was agreed to purchase more grit in July/August.
